- **1.1** Nikkyo collects the following data:
 - A) Personal identification information (Name, email address, phone number, etc.)
 - B) Anonymous website traffic

2. How We Collect Your Information

- **2.1** You directly provide Nikkyo with most of the information we collect. We collection information when you:
 - A) Register for membership on Nikkyo website

- C) Voluntarily complete a customer survey or provide any feedback via email
- D) Use or view Nikkyo website via your browser's cookies

3. How We Use Your Information

- **3.1** Nikkyo collects your data so we can:

 - C) With your consent, your reviews will be posted on the website
 - D) Analytical data used to determine website traffic, most viewed or most purchased vehicles.

4. How We Store Your Information

4.1 Nikkyo securely stores your information on servers at Nikkyo headquarters and partner web services.

5. Marketing
